**DIVISION MONITORING ON EXPANDED GOVERNMENT ASSISTANCE TO
STUDENTS AND TEACHERS IN PRIVATE EDUCATION (EGASTPE)
IMPLEMENTATION**

1. Schools Division Offices through the Monitoring Section, In-Charge of Private Schools, and the PSDSs of the Curriculum Implementation Division (CID) are hereby directed to monitor the implementation of the EGASTPE among private schools.
