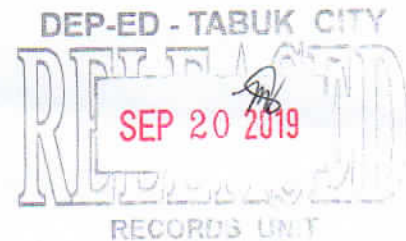

1. This is to announce that there will be a Planning Conference on the conduct of the 2019 Division Festival of Talents in MAPEH to all elementary and secondary schools including the ALS on October 1, 2019 at the Davidson Hotel, Bulanao, Tabuk City at 8:30 in the morning.
2. Objectives of this planning conference are as follows:
 - a. discuss the guidelines and mechanics of the contested activities;
 - b. elect officers/coordinators in MAPEH per district.
3. The activities of the festival of talents are as follows:
 - a) **Bayle sa Kalye** (Street Dancing) composed of twenty five (24) members and one (1) coach.
 - b) **Likhawitan** (OPM Song Writing contest) consist of five (4) members with one (1) coach.
 - c) **Pintahusay** (On the Spot Painting contest) which compose of one (1) contestant and one (1) coach.
 - d) **Sineliksik** (Film Viewing and Script Writing contest) composed of two (2) members and one (1) coach.
 - e) **Sulatanghal** (Playwriting) with one (1) **contestant** and one (1) coach.
 - f) **Direk Ko, Ganap Mo** (Acting) which compose of two (2) contestants and one (1) coach.
 - g) **Himig Bulilit** (Children's choir of 12 members with 2 SPED learners)
 - h) **Folk Dance** (3 pairs accompanied by one (1) coach) Elementary
