Provision of Reproduction , Packaging and Delivery of Learning Modules for Grade 8 (Araling Panlipunan, Arts , English, ESP , Health, PE , Science & Math)

THIS AGREEMENT made the \(\sum_{\text{th}} \) day September 2020 between the Department of Education, Schools Division of Tabuk City of the Philippines (hereinafter called "the Entity") of the one part and Sta. Barbara Printshop and General Merchandise, Zone 2, Tuliao, Sta. Barbara, Pangasinan (hereinafter called the: Supplier") of the other part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz, **Provision of Reproduction**, **Packaging and Delivery of Learning Modules for Grade 8 (Araling Panlipunan, Arts , English, ESP , Health, PE , Science & Math) (Lot 4)** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum on of Two Million One Hundred Ninety Thousand Three Hundred Fifteen Pesos and Sixty Eight Centavos (Php 2,190,315.68) hereinafter called "the Contract Price".

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
- 2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz:
- (a) the Supplier's Bid, including the Technical and Financial Proposals, and all other documents/ statements submitted (e.g. bidder's response to clarifications on the bid), including corrections to the bid resulting from the Procuring Entity's bid evaluation;
- (b) the Schedule of Requirements:
- (c) the Technical Specifications;
- (d) the General Conditions of the Contract;
- (e) the Special Conditions of Contract;
- (f) the Performance Security; and
- (g) the Entity's Notice of Award.
- In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract
- 4. The Contract duration or completion period shall be Fifteen (15) days after the receipt of the Notice to Proceed by the Supplier.
- 5. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contracts at the time and in the manner prescribed by the contract.
