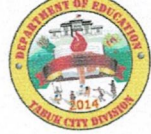

WHEREAS, the Schools Division Office of Tabuk City advertised Invitation to Bid for the **Project : LOT 4 Provision of Reproduction , Packaging and Delivery of Learning Modules for Grade 8 (Araling Panlipunan, Arts , English, ESP , Health, PE , Science & Math) , Provision of Reproduction, Packaging and Delivery of Learning Modules Batch I** posted the same in the PhilGEPS and SDO Tabuk City website , and in a conspicuous place at the premises of School Division Office;

WHEREAS, on August 26 , 2020 at 10:00 AM , the Bids and Awards Committee (BAC) held the pre-bid conference which was attended physically by the two prospective bidders and two participated through online;

WHEREAS, on September 7, 2020 @10:00AM, the scheduled opening of bids, three bidders submitted its bid proposal.

WHEREAS, during the opening of bid at 10:00AM, 2 bid proposals passed the technical documents and one declare non-responsive .

WHEREAS, the detailed evaluation of this bid conducted thereafter, resulted were the following:

WHEREAS, upon conduct of the arithmetic evaluation, the result showed that the total bid as computed was Two Million One Hundred Ninety Thousand Three Hundred Fifteen Pesos and Sixty Eight Centavos (Php 2,190,315.60) and still the lowest calculated bidder.

WHEREAS, upon post qualification , careful examination , validation and verification of all eligibility ,technical and financial requirements submitted by the bidder with the Lowest calculated responsive bid , Sta. Barbara Printshop and General Merchandise, its bid had been found to be responsive.

NOW, THEREFORE, We, the Members of the Bids and Awards Committee hereby resolve as it is hereby **RESOLVED**:

- To declare the Sta.
