**PROVISION OF LEARNING RESOURCES, EQUIPMENT, SUPPLIES AND MATERIALS SY 2022-2023 IN THE IMPLEMENTATION OF BE-LCP 2022-2023**

**CONTRACT AGREEMENT**

THIS AGREEMENT made the \_\_\_\_\_ day of SEP 26 2022 between Schools Division of Tabuk City of the Philippines (hereinafter called "the Entity") of the one part and J & G General Merchandise of Bulanao Centro, Tabuk City, Kalinga, Philippines (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, **particularly PROVISION OF LEARNING RESOURCES, EQUIPMENT, SUPPLIES AND MATERIALS SY 2022-2023 IN THE IMPLEMENTATION OF BE-LCP 2022-2023** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of ONE MILLION FOUR HUNDRED FORTY THREE THOUSAND SIX HUNDRED TWENTY PESOS (Php 1,443,620.00) (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:


1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
  - i. Philippine Bidding Documents (PBDs);
    - i. Schedule of Requirements;
    - ii. Technical Specifications;
    - iii. General and Special Conditions of Contract; and
    - iv. Supplemental or Bid Bulletins, if any
  - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;  
  
Bid form, including **all** the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
  - iii. Performance Security;
  - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
  - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs.

3. In consideration for the sum of ONE MILLION FOUR HUNDRED FORTY THREE THOUSAND SIX HUNDRED TWENTY PESOS ( Php 1,443, 620.00) or such other sums as may be ascertained, J & G General Merchandise agrees to provide the goods in accordance with his/her/its Bid.
4. The Contract Duration or completion period shall be One Hundred Twenty (120) days after the receipt of the Notice to Proceed by the Supplier
5. The *Schools Division of Tabuk City* agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.


